Commencing at point 57 1/2 feet West of the Southeast corner of Lot 15, Block 3, Five acre Plat II, Big Field Survey and running thence North 115 55 feet, thence West 46 1/2 feet, thence South 143 55 feet, thence East 75 1/2 feet to the place of beginning. Subject to and together with a right of way over the strip of ground commencing at a point 115 55 feet South of the Northwest corner of Lot 5, in Block 3 of Plat aforesaid and running thence West 720 feet to the East line of 8th east Street, thence South 50 feet, thence East 726 feet to the West line of 9th east Street, thence North 50 feet to the place of beginning.
