The State of Utah, Department of Natural Resources, Division of Wildlife Resources, 1596 West North Temple, Salt Lake City, Utah 84116, hereinafter referred to as GRANTOR, hereby grants to US West Communications, 250 Bell Plaza, Rucm 1110A, Salt Lake City, Utah 84111, hereinafter referred to as GRANTEE, an Easement to install a buried telephone line conduit on land owned by GRANTOR in Salt lake County, State of Utah. Said Fasement shall be within Section 14, Township 1 South, Range 2 West, SLB&M; more particularly described as follows:

An easement ten (10) feet in width described by a center line with 5 (five) feet on each side as follows:

A. Commencing West 72 feet from the Northcast corner of Section 14, Township 1 South, Range 2 West, SLB&M, thence South 0°14' East 4500 feet more or less to the North line of frontage road. Less street. Containing 1.03 acres more or less.

Also, an easement ten (10) feet in width five (5) feet on each side of telephone facilities 3248 feet more or less, per Exhibit A and Exhibit B attached hereto and made a part hereof. Containing 0.75 acres, more or less.

The Easement herein granted shall be only for the purpose of the installation, operation, inspection, repair, maintenance, replacement or removal of the conduit and concrete. Access is herein granted only for the purpose of such installation and maintenance and not for any other travel or use.

The grant and other provisions of this Easement shall constitute a covenant running with the land for the benefit of the GRANTEE, successors and assigns.

Payment is due upon request of Nine Thousand and Seventy Eight (\$9078.00) dollar; as a one time fee which shall be paid by the GRANTEE to the GRANTOR.

The Easement herein granted is further subject to the following conditions:

- A designated Division of Wildlife Resources representative will be the principal contact to answer any questions and issue a letter of final inspection and approval of the work.
- Any disturbed areas will be seeded with a seed mix recommended and provided by the GRANTOR at the expense of the GRANTEE.
- 3. The GRANTEE shall indemnify and save harmless the State of Utah, the GRANTOR and their officers, agents and employees from and against any and all loss, damages, injury, liability and claims therefore, including claims for personal injury or death, damages to personal property and liens of materialmen, however caused, resulting directly or indirectly from the GRANTEE'S use of this Easement.
