CORRECTIVE RIGHT OF WAY AND EASEMENT GRANT

RURAL ENTERPRIZES, a Utah limited partnership, Grantor, does hereby quit-claim to MOUNTAIN FUEL SUPPLY COMPANY, a Corporation of the State of Utah, Grantee, its successors and assigns, for the sum of One and 00/100 (\$1.00) and other good and valuable considerations, receipt of which is hereby acknowledged, a right of way and easement to lay, maintain, operate, repair, inspect, protect, remove and replace pipe lines, valves, valve boxes and other gas transmission and distribution facilities (hereinafter collectively called "facilities") through and across the following described land and premises situated in the County of Salt Lake, State of Utah, and more particularly described as follows, to wit:

Beginning at a point North 540.57 feet and West 1264.46 feet from the South Quarter Corner of Section 10, Township 2 South, Range 1 West, Salt Lake Base and Meridian; thence N.0°13'19"W. 16.00 feet, thence East 13.50 feet, thence North 105.45 feet, thence East 1197.80 feet, thence South 16.00 feet, thence West 314.80 feet, thence South 30.00 feet, thence West 16.00 feet, thence North 30.00 feet, thence West 271.00 feet, thence South 171.00 feet, thence West 16.00 feet, thence North 171.00 feet, thence West 209.00 feet, thence South 171.00 feet, thence West 16.00 feet, thence North 171.00 feet, thence West 123.00 feet, thence South 171.00 feet, thence West 16.00 feet, thence North 171.00 feet, thence West 200.00 feet, thence South 135.45 feet, thence West 16.00 feet, thence North 30.00 feet, thence West 13.50 feet to the point of beginning.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such facilities shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, inspect, protect, remove and replace the same. During temporary periods Grantee may use such portion of the property along and adjacent to said right of way as may be reasonably necessary in connection with construction, maintenance, repair, removal or replacement of the facilities. The said Grantor shall have the right to use the said premises except for the purposes for which this right of way and easement is granted to the said Grantee, provided such use does not interfere with the facilities or any other rights granted to the Grantee hereunder.

The Grantor shall not build or construct nor permit to be built or constructed any building or other improvement over or across said right of way, nor change the contour thereof without written consent of Grantee. This right of way grant shall be binding upon and inure to the benefit of the successors and assigns of Grantor and the successors and assigns of the Grantee, and may be assigned in whole or in part by Grantee.

Grantee hereby acknowledges that this is a Corrective Right of Way and Easement to the Rights of Way and Easement Grants dated June 11, 1980, and recorded June 24, 1980, in the office of the County Recorder of Salt Lake County, in Book 5115 at Pages 1258 and 1259, and dated April 9, 1982, and recorded May 10, 1982, in the office of the County Recorder of Salt Lake County in Book 5370 at Pages 707 and 708, and that by acceptance hereof, Grantee hereby

It is hereby understood that any parties securing this grant on behalf of the Grantee are without authority to make any representations, covenants or agreements not herein expressed.

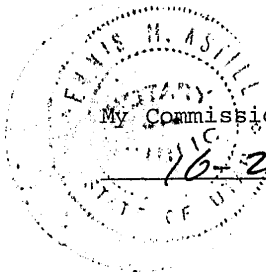

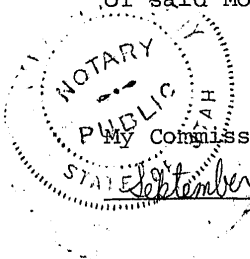
