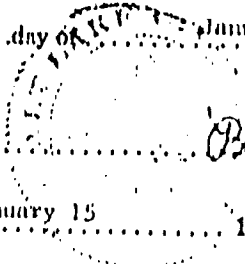

SALT LAKE CITY ORDINANCE  
No. 1 of 1992  
Amending a portion of the Centennial Park  
Subdivision Phase II  
pursuant to Petition No. 400-953-91)

AN ORDINANCE APPROVING THE AMENDMENT OF A PORTION OF THE CENTENNIAL PARK SUBDIVISION PHASE II AS REQUIRED BY SECTION 57-5-8, UTAH CODE ANNOTATED PURSUANT TO PETITION NO. 400-953-91.

WHEREAS, Petition No. 400-953-91 was filed with the City by Duane Iverson, as agent for Iverson Investment, requesting the City to allow the amendment of a portion of the Centennial Park Subdivision Phase II; and

WHEREAS, one hundred percent (100%) of the owners of the property within and adjacent to the subdivision have not consented to the amendments; and

WHEREAS, the City Council has held a public hearing after giving the required notices, and has reviewed the proposed amendment which has been previously approved by the Planning Commission on August 22, 1991; and

WHEREAS, good cause exists for the amendment of the subdivision and the City Council finds that neither the public nor any person will be materially injured by the proposed amendment;

NOW, THEREFORE, be it ordained by the City Council of Salt

SECTION 1. The City hereby approves the proposed amendment Centennial Industrial Park Phase II Subdivision approved by the Planning Commission on August 22, 1991.

SECTION 2. EFFECTIVE DATE. This ordinance shall become effective on the date of its first publication and shall be recorded with the Salt Lake County Recorder.
