An easement and right-of-way to construct, maintain, repair, use and operate any railroad trackage, railroad switches, railroad equipment or railroad facilities which may to Grantee seem advantageous, convenient or beneficial in the use and operation of a blast furnace known as Plast Furnace Number Two at Ironton, Utah, over, upon and along the following described real property situate in Utah County, State of Utah:
