PIPELINE - SPRINGVILLE REACH,  
UTAH LAKE DRAINAGE BASIN WATER DELIVERY SYSTEM,  
BONNEVILLE UNIT, CENTRAL UTAH PROJECT

Utah Department of Transportation ("UDOT"), 4501 South 2700 West, Salt Lake City, Utah 84119, Grantor, grants and conveys to the United States, Department of the Interior, Grantee, hereinafter referred to as "United States" or "Interior".

UDOT hereby conveys and grants to the United States, its successors and assigns with the United States acting pursuant to the Reclamation Act of June 17, 1902 (32 Stat. 388), and acts amendatory thereof and supplementary thereto, particularly the Act of April 11, 1956 (70 Stat. 105, 43 U.S.C. § 620 *et seq.*), and pursuant to the provisions of the Reclamation Projects Authorization and Adjustment Act of 1992, P.L. 102-575, the following described perpetual but non-exclusive easement situated in the County of Utah, State of Utah, to-wit:

Five parcels of land situated in Sections Seventeen (17), Twenty (20), Twenty-One (21), and Twenty-eight (28), Township Seven (7) South, Range Three (3) East, Salt Lake Base and Meridian, containing a combined area of 5.61 acres, more or less, more particularly described following:

**Parcel No. 12:EQ,**

Consisting of Department of the Interior Parcel

ULS-SFP-17(P).

A parcel of land situated in the Northwest Quarter of Section Twenty-Eight (28), Township Seven (7) South, Range Three (3) East, Salt Lake Base and Meridian, containing an area of 0.42 acres, more or less. The boundary of said parcel of land is described as follows:

Parcel No. ULS-SFP-10(P), ULS-SFP-11(P), ULS-SFP-12(P), ULS-SFP-13(P), and ULS-SFP-16(P) contain a combined total of Five and Sixty-one Hundreths (5.61) acres, more or less.

Construction, operation, and maintenance of the Pipeline will be conducted by Central Utah Water Conservancy District ("CUWCD") pursuant to the terms in the Statewide Utility License Agreement between UDOT and CUWCD, Federal ID No. 870267073, dated April 23, 2002. The terms in the Statewide Utility License Agreement are fully

incorporated into this Grant of Easement.

United States shall comply with all applicable laws, ordinances, rules, and regulations.

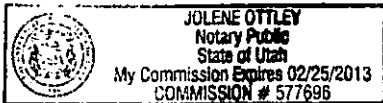
