

## LEGAL DESCRIPTION

A parcel of land in fee, being part of an entire tract of property, situate in the North half of the Southwest Quarter of Section 18, Township 5 South, Range 2 East, Salt Lake Base and Meridian, in Utah County, State of Utah, for the widening of the existing North County Boulevard, known as Project No. RD920. The boundaries of said parcel of land are described as follows:

Beginning at the Northwest corner of said entire tract, said point also being at the intersection of the existing Easterly right of way line of North County Boulevard (4650 West Street) and the Southerly right of way line of 300 North Street which point is 543.90 feet South and 1,175.93 feet East from the West Quarter corner of said Section 18; and running thence East 86.18 feet along said Southerly right of way line; thence South 00° 10′ 18" West 2.66 feet; thence South 65° 43′ 43" West 73.01 feet; thence South 00° 08′ 35" West 132.33 feet to the Southerly boundary line of said entire tract; thence West 19.29 feet along said Southerly boundary line; thence North 165.00 feet along said Easterly right of way line to the point of beginning.

A perpetual easement, upon part of an entire tract of property, situate in the North half of the Southwest quarter of Section 18, Township 5 South, Range 2 East, Salt Lake Base and Meridian, in Utah County, State of Utah, for the purpose of constructing thereon cut and/or fill slopes and appurtenant parts thereof to facilitate the widening of the existing North County Boulevard, known as Project No. RD920. The easement includes the right to maintain and continue the existence of said cut and/or fill slopes in the same grade and slope ratio as constructed by Utah County. The easement shall run with the Real Property and shall be binding upon the Grantor and the Grantors successors, heirs and assigns, and includes and conveys all rights of grantor to change the vertical distance or grade of said cut and/or fill slopes.
