DEED OF EASEMENT

PAUL A. KOS AND BERTHA P. KOS, Husband and Wife of Rocksprings, County of Sweetwater, State of Wyo., hereinafter referred to as Grantor, hereby conveys to THE UNITED STATES OF AMERICA, acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat., 388) and acts amandatory thereof or supplementary thereto, Grantee, for the sum of One Dollar (\$1.00), a perpetual easement to construct, reconstruct, operate and maintain an underground pipeline or pipelines and appurtenant structures which latter may protrude above the ground on, over or across the following described property in Weber County, State of Utah:

A strip of land in the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Fifteen (15), Township Five (5) North, Range One (1) West, Salt Lake Base and Meridian, Twenty (20.0) feet wide and included between two lines extended to the property lines and everywhere distant Ten (10.0) feet on the right or North side and Ten (10.0) feet on the left or South side of that portion of the following described centerline of what is known as the Uintah Bench Lateral 4.1L from Station 16+29.0 to Station 24+20.0 measured at right angles thereto; said centerline is more particularly described as follows:

Beginning at Station 16+29.0, a point on the East line of the Grantor's property from which point the Northwest corner of said Section 15 bears North 38°11' West Sixteen Hundred Eight-three and Four-tenths (1683.4) feet, and running thence North 89°50' West Fifteen and Nine-tenths (15.9) feet; thence South 45°12' West Twenty-two and Seven-tenths (22.7) feet; thence North 89°50' West Seven Hundred Fifty-two and Five-tenths (752.5) feet, to Station 24+20.0 a point on the West line of the Grantor's property, also being a point on the East line of State Highway U-103, from which point the Northwest corner of said Section 15 bears North 10°50' West Thirteen Hundred Sixty-one and Three-tenths (1361.3) feet, containing 0.36 of an acre, more or less; also,

A tract of land in the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Fifteen (15), Township Five (5) North, Range One (1) West, Salt Lake Base and Meridian, being more particularly described as follows:

Beginning at a point on the centerline of what is known as the Uintah Bench Lateral 4.1L-0.1L at Station 12+84.3, a point on the Northeasterly line of the Grantor's property, also being a point on the Southwesterly line of the Old Post

Road, from which point the Northwest corner of said Section 15 bears North 39°49' West Twenty Hundred Ninety-three and Seven-tenths (2093.7) feet, and running thence South 0°06' West along the East line of the Grantor's property Two Hundred Fifty and Seven-tenths (250.7) feet to the Southeast corner of the Grantor's property; thence West along the South line of the Grantor's property Ten (10.0) feet; thence North 0°06' East Two Hundred Sixty and Seven-tenths (260.7) feet, more or less, to a point on the Northeasterly line of the Grantor's property and the Southwesterly line of the said Old Post Road; thence South-easterly along said road Fourteen and Two-tenths (14.2) feet, more or less, to the point of beginning, containing 0.06 of an acre, more or less.
