## 4964 Warranty Deed

A parcel of land in fee for an expressway known as Project No. 028-1, being part of an entire tract of property, in the NW $\frac{1}{2}$ NW $\frac{1}{2}$  of Section 20, T. 8 S., R. 3 E., S.L.B.&M. The boundaries of said parcel of land are described as follows:
