WATER LINE EASEMENT

The University of Utah, a body politic and corporate of the State of Utah, as ground lessor, and Gardner-Daybreak Office 1, L.C., a Utah limited liability company, as ground lessee (collectively "GRANTOR"), for and in consideration of ten dollars (\$10.00) and other good and valuable consideration, hereby GRANTS AND CONVEYS to the CITY OF SOUTH JORDAN, a municipal corporation of the State of Utah ("GRANTEE") and its successors and assigns a permanent easement for water line facilities and appurtenances thereto (the "EASEMENT") upon the following described property situated in Salt Lake County, Utah, and legally described as follows:

Beginning at a point being North 89°56′03″ West 7,245.26 feet along the Daybreak Baseline South (Basis of bearings is South 89°56′03″ East 21,225.293 feet from the Southwest Corner of Section 22, T3S, R2W and the Southeast Corner of Section 19, T3S, R1W) and North 1,554.16 feet from the Southeast Corner of Section 19, Township 3 South, Range 1 West, Salt Lake Base and Meridian, said point also being South 89°58′42″ East 719.23 feet along the section line and North 1,549.78 feet from the South Quarter Corner of Section 24, Township 3 South, Range 2 West, Salt Lake Base and Meridian; and running

GRANTEE reserves the EASEMENT, so long as GRANTEE determines that such water line facilities shall be required, with the right of ingress and egress to GRANTEE and its officers, employees, representatives, agents, and assigns to enter upon the EASEMENT with such equipment as is necessary to construct, install, maintain, repair, inspect, protect, remove, and replace said water line facilities and appurtenances.

GRANTOR shall have the right to use premises except for the purpose for which the EASEMENT is granted to GRANTEE, provided such use shall not interfere with the water line facilities and appurtenances thereto or any other rights granted to GRANTEE hereunder. This waterline easement shall be binding upon, and inure to the benefit of the successors and assigns of GRANTOR and may be assigned in whole or part by the GRANTEE.

GRANTOR reserves the right to substitute a new easement location if, in the opinion of GRANTOR, such relocation is necessary; however, should GRANTOR elect to make such a substitution, the cost of relocating GRANTEE's facilities shall be paid in full by GRANTOR and a new substitute easement shall be provided to GRANTEE at no cost to GRANTEE.

GRANTEE agrees to indemnify and hold harmless GRANTOR from any and all loss, damage, expense, claims or demands resulting from the negligence of GRANTEE in connection with its use of the easement or the construction, operation, maintenance, repair, relocation or replacement of GRANTEEs facilities on the right of way.


In the event GRANTEE should no longer use the easement for the purposes for which this easement has been granted, the easement will revert back to GRANTOR.
