CORRECTED MEMORANDUM OF  
WATER DELIVERY AGREEMENT  
(Daybreak Water Company)

This CORRECTED MEMORANDUM OF WATER DELIVERY AGREEMENT (this "*Corrected Memorandum*") is entered into on this 6<sup>th</sup> day of September, 2016 by and between KENNECOTT WATER DISTRIBUTION LLC, a Delaware limited liability company, with an address of 4700 Daybreak Parkway, South Jordan, Utah 84009 ("*Kennecott Water Distribution*"), and DAYBREAK WATER COMPANY, a Utah nonprofit corporation, with an address of 4700 Daybreak Parkway, South Jordan, Utah 84009 (the "*Company*").

A. Kennecott Water Distribution and the Company entered into that certain Water Delivery Agreement, dated August 17, 2015 (the "*Agreement*"), pursuant to which Kennecott Water Distribution has agreed to deliver the Daybreak Water to the Company for the irrigation of parks, open space and commercial landscaping and to supply water to Oquirrh Lake located on land owned by the Company's shareholders within or immediately adjacent to the master planned community of Daybreak in South Jordan, Utah (the "*Daybreak Project*"). Capitalized terms not otherwise defined herein have the meaning set forth in the Agreement.

B. Kennecott Water Distribution is the holder of certain rights and interests authorizing the use of the real property described in Exhibit A (the "*Real Property*") for Kennecott Water Distribution's Water Delivery System.

C. Kennecott Water Distribution and the Company executed the Memorandum of Water Delivery Agreement dated July 15, 2016, and recorded July 18, 2016, as Entry No. 12322189, in Book No. 10453, at Page No. 3752 of the office of the Salt Lake County Recorder (the "*Memorandum*") to provide notice of the Agreement. Exhibit A of the Memorandum contained errors in the legal descriptions of the real property.

D. Kennecott Water Distribution and the Company have agreed to enter into and record this Corrected Memorandum in the real property records of Salt Lake County, Utah, to correct the errors in the legal descriptions of the real property in Exhibit A of the recorded Memorandum.

Among other provisions, the Agreement provides the following:

1. Term. The term of this Agreement commenced as of August 17, 2015 and is perpetual, except and unless it is terminated as follows: (a) by mutual written agreement of the Parties, (b) by Kennecott Water Distribution in the event that the Utah Public Service Commission or and successor agency makes a determination that Kennecott Water Distribution is a regulated public utility; or (c) automatically upon the closing of the transfer of the Water Delivery System from Kennecott Water Distribution to the Company following the exercise of the Put Option set forth in Section 8 of the Agreement.

2. Put Option for Transfer of Water Delivery System/Transfer of Water Delivery System to Other Third Party. The Company has granted to Kennecott Water Distribution an exclusive and irrevocable put option to transfer all right, title, and interest in and to the Water Delivery System to the Company, free and clear of liens, claims, and encumbrances (the "*Put Option*"), which can be exercised according to the terms provided in the Agreement.

3. Assignment. Neither the Agreement nor any of the rights, interests or obligations may be assigned by any of the Parties, in whole or in part (whether by operation of law or otherwise), without the prior written consent of the other Party, and any attempt to make any such assignment without such consent shall be null and void, except that: (a) without the Company's consent, Kennecott Water Distribution may assign, in its sole discretion, any or all of its rights, interests and obligations under the Agreement to any entity that is wholly owned by or affiliated with Kennecott Water Distribution; and (b) without the consent of the Company, Kennecott Water Distribution may assign, in its sole discretion, any or all of its rights, interests and obligations under the Agreement to any entity that will acquire all or substantially all of Kennecott Water Distribution's assets or ownership interest.

4. Miscellaneous. This Corrected Memorandum is executed for the purpose of providing third parties with notice of the existence and effect of the Agreement, and reference to the Agreement is hereby made for greater particularity as to the terms, conditions, and provisions set forth therein. In the event of any inconsistency or dispute between this Corrected Memorandum and the Agreement, the terms of the Agreement shall control and prevail. This Corrected Memorandum may be executed in counterparts, each of which is to be deemed original for all purposes, but all of which together shall constitute one and the same instrument.

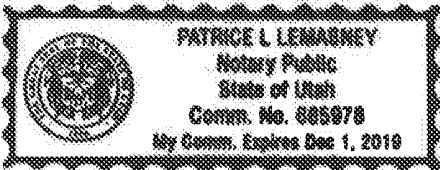

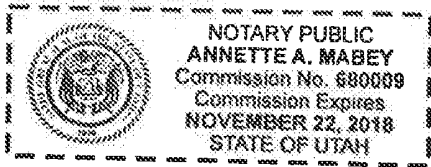
