Whereas Samuel M. Butcher, of Salt Lake County, Utah Territory, has deposited in the General Land Office of the United States a certificate of the Register of the Lands Office at Salt Lake City, Utah Territory, whereby it appears that full payment has been made by the said Samuel M. Butcher, according to the provisions of the Act of Congress of the 24<sup>th</sup> day of April, 1850, entitled an Act making further provision for the sale of the Public Lands and the acts supplementary thereto, for the North half of the South East quarter and the South East quarter of the South East quarter of Section fifteen and the North East quarter of the North East quarter of Section twenty two in Township three South & Range Three West of Salt Lake Meridian in Utah Territory containing one hundred and sixty acres according to the Official Plat of the Survey thereon shown up, that the United States of America, in consideration of the premises, and in conformity with the several Acts of Congress in such cases made and provided, have granted and by these presents do give and grant, unto the said Samuel M. Butcher and to his heirs the said tract above described:

To have and to hold the same, together with all the rights, privileges, immunities, and appurtenances of whatever nature thereunto belonging unto the said Samuel M. Butcher and his heirs and assigns forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws and decisions of courts, and also subject to the right of the proprietor of a vein to locate to extract and remove his ore therefrom, should the same be found to penetrate or intersect the premises hereby granted, as provided by law.

In testimony whereof, Benjamin Harrison, President of the United States of America, has caused these letters to be made patent, and the seal of the General Land Office to be hereunto affixed.

Given under my hand, at the City of Washington, the fourth day of September in the year of our Lord one thousand eight hundred and ninety, and of the Independence of the United States the one hundred and fiftieth.
