FENCE AND USE AGREEMENT

CORPORATION OF THE PRESIDENT OF THE CHURCH OF JESUS CHRIST

OF LATTER-DAY SAINTS, a Utah Corporation Sole, hereinafter referred
to as "Church", and ELEANOR S. ZIMMERMAN and CLIFFORD JOHN ZIMMERMAN,
as Trustees of the Eleanor Grace Stephenson Zimmerman Family Living
Trust, hereinafter referred to as "Zimmerman", hereby agree as follows:

WHEREAS, Zimmerman has a right-of-way over the property described in Exhibit "A" attached hereto and incorporated herein by reference, (the fee title of which is in the Church);

WHEREAS, the Church is the owner of the real property immediately to the North of said right-of-way;

WHEREAS, the Church desires to erect a barrier fence along the North line of said right-of-way from the West end of Zimmerman's building to Plum Alley;

WHEREAS, the parties acknowledge that construction of the fence exactly on the North right-of-way line will make truck access to Zimmerman's loading dock difficult;

WHEREAS, the Church is willing to locate the fence slightly off the line in order to accommodate Zimmerman's trucks.

IT IS THEREFORE AGREED THAT:

The Church will construct its fence slightly off the North line of the right-of-way. The parties hereby acknowledge that the fence is for the regulation of parking only and is not intended to describe or mark the boundary line between the Church parcel and Zimmerman's right-of-way. Zimmerman agrees that its use of any part of the Church's property is with the Church's express permission and that said permission may be revoked and the fence moved to the boundary line at any time. The parties agree that any use by Zimmerman of any Church property shall not be considered adverse and shall not expand Zimmerman's right-of-way. Zimmerman agrees to repair

BEGINNING at a point located 38.78 feet South 0°03'21" West, along the East block line, and North 89°51'15" West 201.69 feet from the Northeast corner of Lot 1, Block 70, Plat "A", Salt Lake City Survey, and running thence North 89°51'15" West 33.31 feet to the East right-of-way line of Plum Alley; thence South 0°03'21" West 72.319 feet along said East right-of-way line; thence South 89°51'50" East 53.50 feet; thence North 0°03'21" East 11.62 feet; thence North 89°52'48" West 14.16 feet to an overhead ramp; thence along the Eastern projection of said overhead ramp along a 46.00 feet curve to the left 33.92 feet (long chord bears North 10°25'12" West 33.158 ft.); thence North 0°03'21" East 28.10 feet to the point of BEGINNING.
