### NOTICE OF PRESCRIPTIVE EASEMENT

HAIGHTS CREEK IRRIGATION COMPANY, a Utah nonprofit mutual water company (the "Company"), whose mailing address is 820 East 200 North, Kaysville, Utah 84037, pursuant to and in conformance with the provisions of §57-13a-103, Utah Code Annotated, 1953, as amended (the "Statute"), hereby gives notice that it, being a water user as defined in the Statute, has duly established a perpetual prescriptive easement and right of way, including rights of ingress and egress, over, under, across and through the land described herein, by virtue of the continuous, open, notorious and adverse use thereof by the Company for a period exceeding 20 years. The described land has been utilized by the Company for the construction, placement, ownership, operation, maintenance, repair and replacement of an underground water pipeline and related facilities (the "Water Facilities"), utilized by the Company for the transportation, distribution and delivery of water to its shareholders and others under water rights recognized under state law, in conformance with the authority of the Statute, including, without limitation, the right, as necessary or convenient for the full and complete use, occupation and enjoyment of said easement to cut and remove structures, timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Company's full use, occupation and enjoyment of said easement; the right to go upon so much of said land as is reasonably necessary to construct, operate, maintain, repair and replace the Water Facilities; and the right to place dirt and materials and use equipment upon the land adjacent to said easement, as necessary for the purposes for which said easement has been established.

A parcel of land 15 feet each side of the described centerline of the existing pipe located in the NW1/4 of Section 1, T.3N., R.1W., S.L.B.&M. thence as follows:


