ORDINANCE DESCRIBING THE BOUNDARIES OF UTAH COUNTY SERVICE AREA  
NO. 9 AND STATING THE TYPES OF SERVICES TO BE PROVIDED THEREIN,  
WHICH INCORPORATES IN BOOK FORM THE AMENDMENTS MADE TO SAID  
SERVICE AREA FROM ITS CREATION TO THE PRESENT

ORDINANCE DESCRIBING THE BOUNDARIES OF UTAH COUNTY SERVICE AREA NO. 9 AND STATING THE TYPES OF SERVICES TO BE PROVIDED THEREIN, WHICH INCORPORATES IN BOOK FORM THE AMENDMENTS MADE TO SAID SERVICE AREA FROM ITS CREATION TO THE PRESENT

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF UTAH ORDAINS AS FOLLOWS:

SECTION I:

1. The boundaries of Utah County Service Area No. 9, which service area was initially created on December 22, 1976, and has been amended variously since its creation, are hereby amended to have those boundaries described in the attached Exhibit A, which exhibit is made a part of this ordinance by this reference.

2. Said service area may provide the following services within the above-described boundaries of said service area: structural fire protection; water conservation; flood control; and local streets and roads.

3. A tax sufficient to pay for all services which are furnished on an extended basis within the above-described boundaries of said service area will be annually levied upon all taxable property within the above-described boundaries of said service area, or a service charge will be collected from the users of services which are furnished on an extended basis within the above-described boundaries of said service area, or a combination to the foregoing property tax and the foregoing service charge, will be used.

4. The Board of County Commissioners of Utah County, State of Utah, and thereafter their duly elected and qualified successors, shall act as the trustees of said service area.

5. The trustees of said service area shall have all rights, powers, and authority granted to trustees of a service area under the provisions of the "County Service Area Act", Section 17-29-1, et. seq., Utah Code Annotated, 1953, as amended.

6. In the event that any section, paragraph, clause, or provision of this Ordinance is for any reason held to be invalid, unconstitutional, or unenforceable, the invalidity, unconstitutionality, or unenforceability of such section, paragraph, clause, or provisions shall not affect the remaining provisions of this Ordinance.

EXHIBIT A

LEGAL DESCRIPTION OF THE BOUNDARIES OF UTAH COUNTY SERVICE AREA  
NO. 9

SCOPE - EXPLANATION

The territory which shall be included within Utah County Service Area No. 9 is described by the precise legal descriptions that follow.

Because the boundaries of Utah County Service Area No. 9 coincide with the boundaries of the A-1 Agricultural Zone, the CE-1 Critical Environmental Zone, and the M&G-1 Mining and Grazing Zone of the Utah County Zoning Ordinance, zoning references are mentioned in the following service area descriptions to aid the users of the document.

A-1 AREAS
