to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing  
under and by virtue of the laws of the State of Utah, Grantee, for the sum of

One DOLLARS (\$1.00) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right  
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through  
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:  
Beg. at a point on a fence cor. N 789.36 ft. & E 392.70 ft fr the SW cor of NE 1/4 of  
Sec. 9, T2S, R1E, SL B & M, said pt being the SE cor of Lot 95, Crown Colony Sub; th  
N 89°27' E 678.94 ft, th N 9°50' W 120.28 ft; th N 89°27' E 94.13 ft m or l to W line  
of Highland Cir; th N 39° W along W line of street 78.09 ft; th N 24°37' W along W line  
of street 49.44 ft m or l to S boundary of J C D Nation prop; th S 86°39' W 123.86 ft;  
th S 89°21' W 110.43 ft; th N 3° W 6.50 ft; th N 89°05' W 122.26 ft; th N 5°24' W 80.30  
ft along an old fence line; th N 3°27' W 56.18 ft m or l, th along fence line N 15°44'  
W 41.08 ft; th along line of fence S 80°00' W 292.31 ft, m or l to the E'rly boundary  
of E M Martin prop., th S 3°00' W 20.20 ft; th S 2°34'15" W 336.50 ft m or l to beg.

the center line of said pipe shall extend through and across the above land and premises on a line  
described approximately as follows:

All main line sewer extensions to serve two or more buildings. Width of easement  
to be 5 feet each side of center line of pipe.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so  
long as such pipe line shall be maintained, with the right of ingress and egress to and from said  
right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor...  
to fully use the said premises except for the purposes for which this right of way or easement is  
granted to the said Grantee.
