MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE (this "Memorandum") is made and entered into by and between University Mall Shopping Center, L.C., a Utah limited liability company ("Landlord"), and Costco Wholesale Corporation, a Washington corporation ("Tenant").

RECITALS:

WHEREAS, pursuant to that certain "Lease" dated to be effective as of June 28, 1999 (the "Lease"), by and between Landlord and Tenant, Landlord leased to Tenant, and Tenant leased from Landlord, certain premises located at 648 East 800 South, Orem, Utah 84097 ("Leased Premises"), consisting of approximately 13.174 acres of land;

WHEREAS, the Leased Premises is located within and constitute a part of a certain mixed-use development commonly known and referred to as "University Place" ("Shopping Center"), being more particularly described on <u>Exhibit A</u> attached hereto and by this reference incorporated herein; and

WHEREAS, Landlord and Tenant desire to disclose to the public their respective interests in and to the Lease, the Leased Premises and the Shopping Center, and certain obligations under the Lease by recording this Memorandum in the official public records of Utah County, Utah.

AGREEMENTS:

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth in the Lease, Landlord and Tenant hereby covenant and agree as follows:

- 1. The "Term" of the Lease commenced on or about December 1, 1999 and pursuant to that certain First Amendment to Lease Tenant has exercised its first Extension Option and, unless sooner terminated or further extended pursuant to the terms of the Lease as amended, will expire on November 30, 2029.
- 2. Tenant has the right and option to renew and extend the Term for six (6) successive periods of five (5) Lease Years each.
- 3. This Memorandum is not intended to alter or supersede the Lease, and in the event of any conflict between the provisions of this Memorandum and those of the Lease, the provisions of the Lease shall control.


