ORDER OF ABANDONISENT OF PUBLIC ROADSAFFILTY COUNTY RECORDER

THIS ORDER of abandonment of certain public roads in Cache. County, Utah, hereinafter described, made pursuant to a Resolution of Abandonment made by the Board of County Commissioners of Cache County, Utah on the \_\_\_\_\_\_ day of February, 1963, and based thereon it is hereby ordered by the Board of County Commissioners that the following described roads in Cache County, Utah, are hereby abandoned as of this date as public roads, which roads are particularly described as follows, to-wit:

Amalga Road Closure for Public Use:

The following is a description of the center line of the Amalga Road West of Smithfield that is to be closed for public use.
