Dear Lt. Governor Herbert:

On November 4, 2008, the voters of the municipalities of Eagle Mountain and Saratoga Springs elected to annex to the UTA, a public transit district and to impose a 1/4 of 1% sales and use tax to fund transit services in these areas.

Pursuant to Utah Code Ann. Section 17B-1-414(2)(a)(ii), UTA is required to file a notice with your office in anticipation of the issuance of a Certificate of Annexation by the Lieutenant Governor pursuant to the provisions of Utah Code Ann. **A RESOLUTION OF THE CITY COUNCIL OF  
 OF EAGLE MOUNTAIN CITY: A PETITION  
 TO THE UTAH TRANSIT AUTHORITY, A TRANSPORTATION DISTRICT  
 OF THE STATE OF UTAH**

WHEREAS, Eagle Mountain City is a municipal corporation of the State of Utah, ("a Municipality") and is authorized under the provisions of Section 17B-1-404 (1)(b), *Utah Code* (as amended) to petition for annexation to a transportation district of all the area within the municipal boundaries of the Municipality; and

WHEREAS, the City Council of Eagle Mountain City finds that it is in the public interest to initiate the process of annexation of the Municipality to the Utah Transit Authority, a transportation district of the State of Utah, by filing a petition for annexation as provided by law and to initiate proceedings for a public election; and

WHEREAS, Exhibit A to this Resolution describes the area proposed to be annexed and Exhibit B to this Resolution is a map of the boundaries of the area of Eagle Mountain City proposed to be annexed; and

WHEREAS, the City Council of Eagle Mountain City intends to authorize the Mayor and other required officials and staff of Eagle Mountain City to proceed as required by law to implement the petition and proceedings described by this Resolution.

NOW THEREFORE, be it resolved by the City Council of Eagle Mountain City, that Eagle Mountain City hereby petitions the Utah Transit Authority, a local transportation district of the State of Utah ("UTA"), to annex the area of the Municipality to UTA and to proceed as required by law under the provisions of Section 17B-1-409, *Utah Code* (as amended), to consider this petition and to provide such public notice and to hold such public hearings on this petition and to provide for all appropriate proceedings required by law including, if necessary, a public election and:


Provided that, Eagle Mountain City shall work in coordination with the Utah Transit Authority to submit the proposal of a public transit tax as part of the *Optional Sales Tax*, not to include .30 percent (.30%) to fund a public transportation system and:



Further provided that, the Mayor and Staff of Eagle Mountain City are authorized to perform and execute all acts required by law to implement the presentation of the questions required by law to be decided by election and otherwise under the provisions of Utah statutes and to cooperate with the Utah Transit Authority to execute all documents and to proceed as necessary to implement the intent of this Resolution.

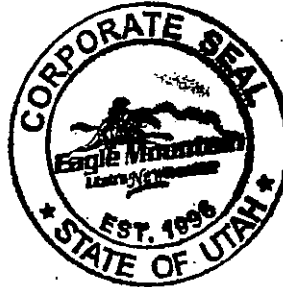



WHEREAS, the Utah Transit Authority (the "Authority") is a public transit district organized under the laws of the State of Utah and was created to transact and exercise all of the powers provided for in the Utah Limited Purpose Local Government Entities-Local Districts Act and the Utah Public Transit District Act; and

WHEREAS, the Board of Trustees (the "Board") previously provided notice of intent to consider providing service and held a public hearing to consider the petition of the municipality of Saratoga Springs (the "Municipality") to annex into the Authority's public transit district pursuant to the Utah Open and Public Meetings Act found at Title 52, Chapter 4 Section 202, *et seq.* and the Limited Purpose Entities- Local Districts Act found at Title 17B, Chapter 1, Sections 407 and 410 *et seq.* of the Utah Code Annotated 1953, as amended as authorized by R2008-09-01; and

WHEREAS, the Authority received a Resolution from the Municipality seeking annexation (the "Resolution") into the public transit district operated by the Authority pursuant to Utah Code Ann. §17B-2a-403. A Copy of the Resolution is attached hereto as Exhibit A; and

WHEREAS, the Board provided notice of a public hearing to registered voters of the Municipality; and

WHEREAS, the election held in the Municipality resulted in an approval of annexation of the Municipality by the majority of the voters in the Municipality; and

WHEREAS, it is considered necessary and desirable by the Board the Authority to adopt a resolution approving the annexation of the Municipality, pursuant to Utah

Code Ann. §§17B-1-412(3)(c)(i) and 414(1)(a) and certify the compliance with annexation requirements of the Authority.


NOW, THEREFORE, BE IT RESOLVED by the Board of the Authority:
