## DEED.

JESSE HULSE and LILLY M.HULSE, his wife, grantors of Delta State of Utah, hereby convey and warrant to THE WESTERN PACIFIC RAILROAD COMPANY, a corporation organized and existing under and by virtue of the laws of the State of California, grantee, for the sum of Five Dollars, the following described strips or tracts of land situate in Tooele County, State of Utah, namely:-

A strip or tract of land 100 feet in width across the west half of southwest quarter of Section 35, Township 2 South, Range 5 West, Salt Lake Base and Meridian said strip or tract of land being bounded on the west by the west line of said Section 35, on the south by the south line of said Section 35, on the northeast and southwest by lines parallel to and 50 feet distant measured northeasterly and southwesterly respectively at right angles or radially from the following described line: Beginning at a point on the south line of said Section 35, 4383.8 feet distant measured westerly along the south line of said Section 35, from the southeast corner of said Section 35, thence North 38°08' West a distance of 1520.4 feet to a point; thence on a 1° curve to the left, tangent to said course, a distance of 93 feet to a point on the west line of said Section 35, 1383.5 feet distant, measured southerly along said west line of Section 35 from the quarter section corner on the said west line of Section 35, Containing approximately 3.7 acres.



## WARRANTY DEED

MCCORMICK INVESTMENT CO., a corporation of Utah, Grantor hereby

CONVEYS and WARRANTS to THE WESTERN PACIFIC RAILROAD COMPANY, a corporation of California Grantee for the sum of Two Hundred Thirty seven Dollars, the following described tract of land in Tooele County State of Utah:

A triangular piece or parcel situated in the southwest quarter of the northwest quarter of Section 17, Township 3 South, Range 4 West, Salt Lake Base and Meridian more particularly described as follows: Beginning at the southwest corner of the southwest quarter of the northwest quarter of said Section 17, thence north  $0^{\circ} 52'$  west along the west line of said southwest quarter of the northwest quarter of Section 17, intersecting the center line of the main track of the grantee's Burmester-Tooele Branch at Engineer's Station 113 $\frac{1}{2}$ .56.5 (M.P.11.553) to a point 50 feet at right angles northerly from the said center line of said main track, a distance of 662.23 feet to a point thence south  $64^{\circ} 34'$  west parallel to and 50 feet at right angles northerly from the said center line of said main tract a distance of 449.6 feet to a point thence southeasterly, parallel to and 50 feet northeasterly at right angles or radially from the said center line of said main track, on a  $3^{\circ} 52'$  curve to the right with a radius of 1482.0 feet a distance of 784.91 feet to point on the south line of the said southwest quarter of the northwest quarter of Section 17, thence south  $89^{\circ} 08'$  west along the said south line of the southwest quarter of the northwest quarter of Section 17, intersecting said center line of said main track at Engineer's Station 102+04.0 (M.P.11.772) a distance of 1022.81 feet to the point of beginning, containing 9.48 acres more or less.
