- 1. <u>Legal Description</u>. Exhibit A attached to the First Supplement is hereby amended, superseded and replaced by Exhibit A attached hereto and made a part hereof.
- 2. <u>Restrictions Regarding Cottages I Neighborhood</u>. The following subparagraph is hereby added to Paragraph 3 of the First Supplement:
 - "(d) Owners of Lots within Cottages I Neighborhood must comply with the requirements of Article VII of the Declaration with respect to the construction of a Unit on a Lot within Cottages I Neighborhood, including without limitation, compliance with the Design Guidelines."
