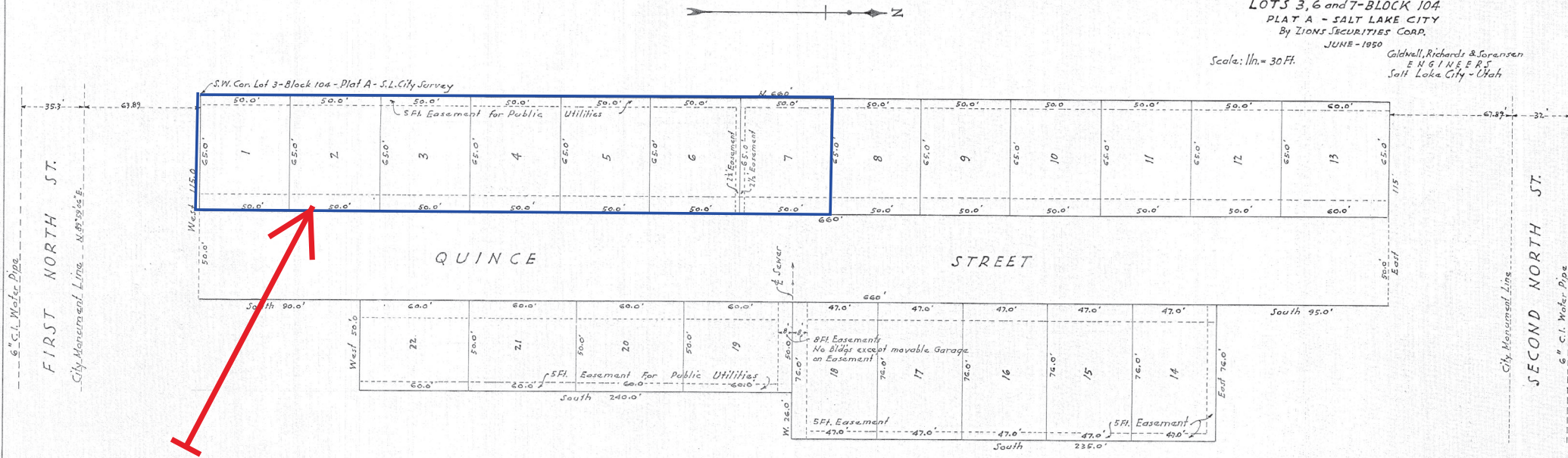


NOALL SUBDIVISION

ENGINEER'S CERTIFICATE

I, A.T. Richards, a registered Professional Engineer and Land Surveyor as prescribed by the Laws of the State of Utah, and holding Certificate No. 821, do hereby certify: That the tract of land shown on this map and owned by Zions Securities Corporation is described as follows: Commencing at the S.W. Cor. of Lot 3, Block 104, Plat A, Salt Lake City Survey, and running thence N. 660 FT.; E. 115 FT.; S. 95 FT.; E. 76 FT.; S. 235 FT.
