RELEASE OF EASEMENT

THIS RELEASE OF EASEMENT is made as of the 5th day of October, 2009 by SANDY CITY ("Sandy City").

WHEREAS utility easements were created pursuant to the plat for the Quarry Bend Subdivision recorded on December 7, 2005 as Entry No. 9575193 in Book 2005P, Page 392 of the Official Records of Salt Lake County, Utah (the "Subdivision Plat"); and

WHEREAS certain utility easements created by the Subdivision Plat were abandoned pursuant to the Notice of Approval of Property Line Adjustment recorded on November 8, 2007 as Entry No. 10270726 in Book 9535, Pages 3382-3389 of the Official Records of Salt Lake County, Utah (the "Property Line Adjustment"),

NOW THEREFORE, Sandy City hereby acknowledges and consents to the abandonment of and waives any interest it may have in the interior utility easement of Lot 8 (described on attached Exhibit "A") shown on the drawing attached hereto as Exhibit "B". In addition, Sandy City hereby abandons and waives any interest it may have in the northern perimeter utility easement of Lot 8 as shown on Exhibit "B". Except as set forth herein, Sandy City rights relating to utility easements along the perimeter of Lot 8 shall remain in full force and effect.

IN WITNESS WHEREOF, Sandy City has executed this Release of Easement as of the 5th day of October, 2009.

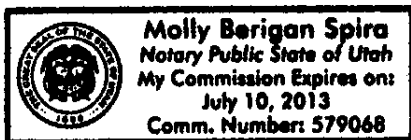
