THE BRIGHAM CITY COUNCIL ORDINANCE NO. <u>12+15</u>

AN ORDINANCE ADOPTING THE CAMPUS DISTRICT COMMUNITY DEVELOPMENT PROJECT AREA PLAN, AS APPROVED BY THE BRIGHAM CITY REDEVELOPMENT AGENCY, AS THE COMMUNITY DEVELOPMENT PROJECT AREA PLAN FOR THE CAMPUS DISTRICT COMMUNITY DEVELOPMENT PROJECT AREA, AND DIRECTING THAT THE REQUIRED NOTICE OF THE ADOPTION BE GIVEN AS SET FORTH IN UTAH CODE ANNOTATED § 17C-4-106.

WHEREAS, the Brigham City Redevelopment Agency (the "Agency"), having prepared a Draft Community Development Project Area Plan for the Campus District Community Development Project Area pursuant to Utah Code Annotated ("UCA") UCA § 17C-4-102, held the required public hearing on the Draft Community Development Project Area Plan on October 18, 2012, pursuant to UCA § 17C-4-102, and thereafter, pursuant to UCA § 17C-4-102 adopted the Draft Community Development Project Area Plan as the Community Development Project Area Plan for the Campus District Community Development Project Area (see Agency Resolution No. 12-19); and

WHEREAS, UCA § 17C-4-105 mandates that before a community development project area plan approved by a Redevelopment Agency under UCA § 17C-4-102 may take effect, it must be adopted by ordinance of the legislative body of the community that created the Agency; and

WHEREAS, UCA § 17C-4-106 also required certain notice to be given by the community legislative body upon its adoption of an economic development project area plan;

NOW, THEREFORE, BE IT ORDAINED BY THE BRIGHAM CITY COUNCIL AS FOLLOWS:

- 1. The Brigham City Council hereby adopts the Campus District Community Development Project Area Plan as approved by the Agency (Agency Resolution No. 12-19), as the Community Development Project Area Plan for the Campus District Community Development Project Area.
- 2. The City Staff is hereby authorized and directed to publish or cause to be published the notice required by UCA § 17C-4-106.
- 3. Pursuant to UCA § 17C-4-106(4), the Agency may proceed to carry out the Community Development Project Area Plan which pursuant to UCA § 17C-4-106(2), shall take effect on the date of publication of the notice required by UCA § 17C-4-106(1).

THE BRIGHAM CITY REDEVELOPMENT AGENCY RESOLUTION NO. <u>12-19</u>

A RESOLUTION OF THE BRIGHAM CITY REDEVELOPMENT AGENCY APPROVING AND ADOPTING THE DRAFT CAMPUS DISTRICT COMMUNITY DEVELOPMENT PROJECT AREA PLAN AS THE PROJECT AREA PLAN FOR THE CAMPUS DISTRICT COMMUNITY DEVELOPMENT PROJECT AREA.

WHEREAS, pursuant to Utah Code Annotated ("UCA") UCA § 17C-4-101, the Brigham City Redevelopment Agency (the "Agency") adopted a resolution authorizing the preparation of a Draft Community Development Project Area Plan for the Campus District Community Development Project Area; and

WHEREAS, the Draft Community Development Project Area Plan (the "Draft Plan") having been prepared for the Campus Area Community Development Project Area, the Agency held, on October 18, 2012 a duly noticed public hearing pursuant to UCA § 17C-4-102, to allow public comment on the Draft Plan and whether the Draft Plan should be revised, approved, or rejected; and to receive all written and hear all oral objections to the Draft Plan; and

WHEREAS, having received and heard all commentary on and objections to the Draft Plan submitted for its consideration the Agency has passed upon said objections as it has received, and has made such modifications, amendments, and recommendations to the Draft Plan as it deemed appropriate if any.

NOW, THEREFORE, BE IT RESOLVED BY THE BRIGHAM CITY REDEVELOPMENT AGENCY AS FOLLOWS:

SECTION 1: ESTABLISHMENT OF THE CAMPUS DISTRICT COMMUNITY DEVELOPMENT PROJECT AREA AND LEGAL DESCRIPTION

There is hereby established the Campus District Community Development Project Area. The boundaries of the Campus District Community Development Project Area (the "Project Area") are legally described in Exhibit "A" attached hereto and incorporated herein as part of this resolution.

SECTION 2: THE AGENCY'S PURPOSES AND INTENT WITH RESPECT TO THE PROJECT AREA

- § 2.1 To facilitate the construction of the Utah Sate University Brigham City Regional Campus.
- § 2.2 To facilitate the rehabilitation or restoration of existing facilities, that (a) will enhance and support the economic development of the community; (b) provide new educational, employment, housing, recreational, social, and cultural opportunities for City residents; (c) enhance the educational, economic, social, and cultural life of Brigham City and Box elder County residents; and (d) harmonize with the atmosphere of Brigham City.
- § 2.3 To encourage, promote, and provide for the Community Development within the Project Area and the City.

SECTION 3: DESIGNATION, ADOPTION, AND INCORPORATION OF THE PLAN

- § 3.1 The Draft Campus District Community Development Project Area Plan, with modifications, if any, recommended following a duly noticed public hearing, comment from affected taxing entities, and owners of property within the Project Area, is hereby designated the Community Development Project Area Plan (the "Plan") for the Campus District Community Development Project Area, and is incorporated herein by this reference.
- § 3.2 The Brigham City Redevelopment Agency hereby officially approves of and adopts the said Plan for the Campus District Community Development Project Area.

SECTION 4: REQUIRED FINDINGS

The Board of the Brigham City Redevelopment Agency hereby makes the following findings:

- § 4.1 The Campus District Community Development Project Area and adoption of the Plan will satisfy a public purpose in facilitating the development of the Utah State University Brigham City Campus, the removal of blight which has previously been found to exist within the Project Area, and the development of adjacent properties not included in the USU campus.
- § 4.2 There is a public benefit under the analysis described in UCA § 17C-4-103 and as described in § 13 of the Plan.
 - § 4.3 It is economically sound and feasible to adopt and carry out the project area plan.
 - § 4.4 The Project Area Plan conforms to the Brigham City General Plan.
- § 4.5 Carrying out the project area plan will promote the public peace, health, safety, and welfare of Brigham City and Box Elder County.

SECTION 5: SUBMISSION OF THE OFFICIAL PLAN TO THE BRIGHAM CITY COUNCIL FOR THE ADOPTION BY ORDINANCE.

Pursuant to Utah Code § 17C-4-105, the Agency Board hereby submits the Campus District Community Development Project Area Plan to the Brigham City Council for its review and adoption.

SECTION 6: RECORDING TRANSMITTAL

Pursuant to Utah Code § 17C-4-106, the Agency Staff is hereby directed and authorized to take the following actions within 30 days after adoption of the Official Plan by the Brigham City Council:

- § 6.1 To publish a notice in a newspaper of general circulation within the Agency's boundaries pursuant to UCA § 17C-4-106(1).
- § 6.2 To record with the Box Elder County Recorder a document containing a description of the land within the Campus Area Community Development Project Area, a statement that the Economic Development Project Area Plan for the Campus District Community Development Project Area has been adopted; and the date of its adoption by the City Council; and

- § 6.3 To transmit a copy of the description of the land within the Project Area and an accurate map indicating the boundaries of the Project Area to each of the Automated Geographic Reference Center created under UCA § 63F-1-506.
- § 6. To transmit a copy of the description of the land within the Project Area, a copy of the City Council ordinances adopting the Official Plan, and a map indicating the boundaries of the Project Area to each of the following: (i) the auditor, recorder, attorney, surveyor, and assessor of Box Elder County; (ii) the legislative body or governing body of each taxing entity; (iv) the State Tax Commission; (v) the State Board of Education.

SECTION 7: EXECUTION OF THE PLAN

Following adoption of the Official Plan by the Brigham City Council, the Agency shall proceed to carry out the Plan.

SECTION 8: DIRECTIONS TO THE AGENCY STAFF

The Agency Staff is hereby directed and authorized to take all such actions as necessary to effectuate the purposes and aims of this resolution

SECTION 9: EFFECTIVE DATE

This Resolution shall take effect upon its adoption.
