The undersigned, being the owners of TAMLEE VILLAGE, are desirous of amending the Restrictions of TAMLEE VILLAGE, and recorded March 18, 1977 as Entry No. 2920428 in Book 4462 at Page 570 of Official Records, to read as follows:

PART B. RESIDENTIAL AREA COVENANTS

1. Land Use and Building Type. No lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any lot other than one detached double-family dwelling not to exceed two stories in height and a private garage and carport for not more than four vehicles. All construction to be of new materials.

ALSO:

3. Dwelling Cost, Quality and Size. No dwelling shall be permitted on any lot at a cost of less than \$50,000.00 including lot, based upon cost levels prevailing on the date these covenants are recorded, it being the intention and purpose of the covenants to assure that all dwellings shall be of a quality of workmanship and material substantially the same or better than that which can be produced on the date these covenants are recorded at the minimum cost stated herein for the minimum permitted dwelling size. The main floor area of the main structure, exclusive of one-story open porches and garages, shall be not less than 900 square feet per unit.
