COMBINED, SHALL BE NO GREATER THAN 35% OR 20 UNITS TOTAL.
THEREFORE, CURRENT OWNERS AND PROSPECTIVE BUYERS MUST
OCCUPY ANY DWELLING LOCATED WITHIN THE ASSOCIATION OR
ELSE IN ORDER TO USE A DWELLING AS NON-OWNER OCCUPIED THEY
