The Party of the second part Witnesseth, that the said party of the first part for and in consideration of the sum of Thirty Dollars lawful money of the United States of America to him in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged has released, released and forever quitclaimed, and by these presents do release, release and forever quitclaim unto the said parties of the second part, and to their heirs and assigns forever, all Commencing at a point centerway of the North boundary line of the S. 17 1/4 of the N. 17 1/4 Sec 22, 2d R. & S. L. W. and running South Westerly one Rod wide for 90 Rods to the S. W. corner of the S. N. 1/4 S. N. 1/4 of aforesaid Sec. Thence S. 52 Rods on the East side yet paralleled with the section line, thence West 20 Rods. Thence S. N. 16 Rods to the East side of the division fence now owned by Ewd Cuttenden and H. and A. Sargent and running South 66 Rods to the lane running East,

Together with all and singular the tenements, hereditaments and appurtenances thereto belonging, or in anywise appertaining, and the severities or aversions, reversions or remainders, rents, issues, and profits thereof; and also the estate, right, title, interest property possession, claim and demand whatsoever, as well in law as in equity of the said party of the first part, of in or to the said premises, and every part and parcel thereof, with the appurtenances.

To have and to hold, all and singular the said premises, together with the appurtenances unto the said parties of the second part, and to their heirs and assigns forever.

The same to be used as a road, and that two gates be maintained and kept shut at the entrance and outlet of said road as long as the crops of the party of the 1st part are liable to damage by stock and at all other times.
