## MEMORANDUM OF LEASE

Lessor does hereby grant, convey and transfer to Lessee the exclusive use and possession of all common laundry facilities on the property, which facility(ies) is/are presently described as encompassing approximately 250 square feet, for its use as a laundry facility(ies).
- 2. **Term.** The term of this Lease is not disclosed herein, but is not less than 1 year nor ore than 20 years from the date of the lease.
- 3. **Assignment or Transfer.** This Lease shall be binding upon the parties hereto, their respective heirs, personal representatives, successors, assigns or transferees.
- 4. Lessor and Lessee have entered into an unrecorded Lease containing the provisions included herein and certain additional provisions. The provisions of the unrecorded Lease are incorporated herein by this reference.
