KNOW ALL MEN BY THESE PRESENTS:

That the undersigned and petition signers, being the owners of all the property and premises situated in Salt Lake County, Utah, and described as follows:

HOFFMAN HEIGHTS #4 Extended, a subdivision in Salt Lake County, Utah, according to the official plat thereof on file and of record in the office of the County Recorder of Salt Lake County, Utah, as Entry #1375898 in Book 0 of Maps, Page 24 thereof; and does hereby establish the nature of the use and enjoyment of all lots in said subdivision and that all conveyances of these lots shall be made subject to the following conditions, restrictions and stipulations:

1. Declaration of Building and Use Restrictions recorded on June 11, 1954 Book 1095 Pages 399 and 400 in the Salt Lake County Recorders office, under Entry #1376287 is amended and corrected as follows:

- (a) Entry #1, which reads "Said lots shall be known and described as "Residential Building Lots" and used for purposes of residence only" should be corrected to read "Said lots shall be known and described as "Residential Building Lots" and used for purposes of residence only except for the site known as Block 21 Hoffman Heights #4 Extended, being bounded by 4520 West Street and 4420 West Street with frontage on 5175 South Street, which has been set aside for the purpose of construction of a church. All other conditions, restrictions and stipulations shall remain in force.
