- 1. <u>Conversion of Convertible Space</u>. In accordance with the terms and conditions of Section 15.04 of the Declaration, Declarant hereby converts the Convertible Space previously designated on the Plat in the manner shown and designated in that certain Plat of East Ridge Professional Office Plaza Condominiums, Amended No. 1, to be recorded in the offices of the Salt Lake County Recorder (the "Amended Plat") simultaneously with the recording of this First Amendment. As a result of such conversion additional Units and Limited Common Area have been added and defined in the Project.
- 2. <u>Amendment to Exhibit "C" Interest in General Common Elements</u>. As a result of the conversion of Convertible Space and the recording of the Amended Plat, each Unit created by such conversion shall be assigned a Unit Number, and the Par Value of all Units shall be recalculated according to the Declaration and the Act. Consequently, the Declarant has amended Exhibit "C" and




