Right of Way for highway purposes known as Wasatch Blvd. across the grantors land in
Section 25, T2S, R1E, S.L.B. & M. Said right of way is described as follows:
Beginning at a point where NW line Gordon & Scott property intersects NE 1/4 R/W Was.
Blvd., said P.T. being S 56°34'00" E 2247.7 feet and S 28°10' W 56.78 feet from NW
corner Section 25, T2S, R1E, S.L.B. & M.; th S 28°10' W 136.42 feet to P.O.C. SW 1/4
R/W Was. Blvd., (R/W curve radius bears S 75°55' W 523.68 feet); th along R/W S 1/4
119.19 feet more or less to intersection with centerline Big Cottonwood Creek;
th SE 1/4 30.76 feet more or less to SE corner said property; th N 28°10' E 128.02 feet

0.3406 Acres more or less.

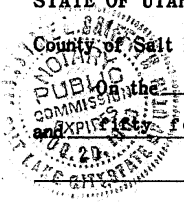
