Received of The Mountain States Telephone and Telegraph Company Five Dollars, in consideration of which I hereby grant unto said Company, its successors and assigns, the right to construct, operate and maintain its lines of telephone and telegraph including one pole, underground conduit and cable, aerial cable, messenger wires and fixtures, upon, over and across the South half of the West 50 feet of Lot 3, Block 30, Plat "A", Ogden City Survey, County of Salt Lake, State of Utah.

This right is granted on condition that the work shall be done with care and any damages caused thereby shall be repaired by and at the expense of said Company.

Provided further that the underground conduit shall be placed within 18 inches of the East line and at a level of 2 feet below the present surface of the ground, and that the pole shall be placed on the East line and about 162 feet North of the South line of the above described property.

Provided further that should the conduit or cables interfere with the erection of new buildings, that the same shall be changed to a location in, on or beneath the wall or the flooring, as designated by the architect or agent of the owner of the said property.

Said sum being received in full payment therefore.
