

and for no other purpose whatsoever; that I will not sub-let it or remove it nor allow it to be removed from Salt Lake County or change the stable or barn where the same is now kept by me, without notifying the said Company of my intention so to do and receiving their consent in writing for the same, and that I will not assign this lease without the written consent of the said Company, and will pay all expenses of repairs and keeping said property, and I further agree to pay to said Company in cash, the value of said property, if same should be destroyed,

But if default shall be made in either of said payments or in any of the conditions of this agreement, or if I shall cease to be in the employ of the said Company for any reason whatsoever, or if I shall sell or offer to sell the said property, or if said property is levied upon for debt, then in that case or at the expiration of the time for which the property is rented, I will return and deliver the same to the said Company in as good condition as when received by me, ordinary depreciation by use excepted, and the said Company or its agents may resume actual possession thereof, and I hereby authorize and empower the said Company or its agents to enter the premises wherever said property may be and take and carry the same away, hereby agreeing to pay all costs and expenses and fees of every kind incurred therein, and hereby waiving any action for trespass or damages therefor and disclaiming any right of resistance thereto, and also waiving all right of homestead or other exemptions under laws of said State as against this obligation.
