ARITICLE 1

Section 1. Items of further clarification as discussed by the trustees on 7.30.2105 at 375 South Main St. Alpine, UT 84004

- 1. Establishment of an association fee for each building owner for execution of the following services:
 - a. Landscape maintenance
 - b. Trash service
 - c. Snow removal
 - d. General liability insurance
- 2. Capitol Expenditures are not drawn from the Association fees but will be accessed on an as needed one time basis as approved by the Board of trustees. This might include items such as:
 - a. Major common area landscaping changes
 - b. Parking lot or pavement improvements
 - c. Any other non-regular service for the benefit of the Old Towne Square as a whole
- 3. Fees are to be collected monthly. An account is to be created with an institution chosen by the board for checking/savings purposes. A member of the board my administer this account or the board my delegate an entity for administration.
- 4. Improvements to the Centre must be approved by the Board that would include items such as signage, landscaping, changes in appearance of facilities.
