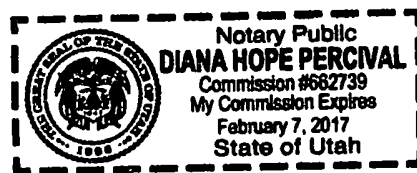

CONCRETE STRUCTURE

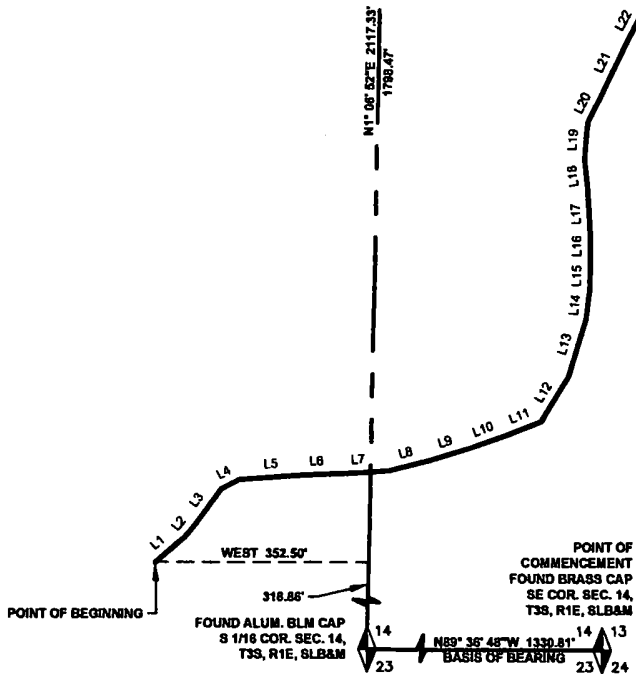
E 1/2 SECTION 14

IRRIGATION DITCH EASEMENT LEGAL DESCRIPTION

Deer Hollow, Draper City, Salt Lake County, Utah

A Prescriptive Easement for the purpose of irrigation, as surveyed more or less along the centerline of an irrigation ditch, with an average width of 4 feet, also known as the 'Draper Irrigation Mountain Stream', located in the East half of Section 14, Township 3 South, Range 1 East, Salt Lake Base and Meridian, Draper City, Salt Lake County, Utah, more particularly described as follows:
