

## RIGHT OF WAY AND EASEMENT GRANT

Woods Cross Canning Co., a Corporation of the State of Utah, Grantor, does hereby convey and warrant to MOUNTAIN FUEL SUPPLY COMPANY, a Corporation of the State of Utah, Grantee, its successors and assigns, for the sum of one thousand /100 DOLLARS (\$1,000.00), receipt of which is hereby acknowledged, a right of way and easement 8 feet in width to lay, maintain, operate, repair, remove and replace pipe lines, valves, valve boxes and other gas distribution facilities through and across the following described land and premises situated in Davis County, State of Utah, to-wit:

The land of grantor, Woods Cross Canning Co., a corporation of the State of Utah, located in part of the north west quarter of the south west quarter of section one, township four north, range two west, Salt Lake Meridian, as more particularly shown on attached Mountain Fuel Supply Company drawing No. 3160, referred to and incorporated herein by reference.

The center line of said right of way and easement shall extend through and across the above described land and premises as follows, to-wit: Center line of gas main located as shown in red on attached drawing #3160, referred to and incorporated herein by reference.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such pipe line or lines, valves or valve boxes and other gas distribution facilities shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, remove and replace the same. The said Grantor to fully use the said premises except for the purposes for which this right of way and easement is granted to the said Grantee.

The Grantor shall not build or construct nor permit to be built or constructed any building or other improvement over or across said right of way. This right of way grant shall be binding upon and inure to the benefit of the successors and assigns of the Grantor and the successors and assigns of the Grantee.


