IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the parcels of land hereinafter described as hereby taken and condemned in fee simple title identified as Parcel Nos. 6D:A and 7B:A for the purpose described and set forth in the Plaintiff's Complaint, i.e., for the use of the Plaintiff, Utah Department of Transportation, for highway purposes.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that said use is a public use and a use authorized by law.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a copy of this Final Order of Condemnation be filed with the County Recorder of Salt Lake County, State of Utah, and thereupon the property interests hereinafter referred to and set forth shall vest in the Plaintiff, Utah Department of Transportation, 4501 South 2700 West, Salt Lake City, Utah 84119. The following is a description of the property condemned as hereinabove provided, which is hereby vested in the Plaintiff, all of such property being situated in Salt Lake County, State of Utah, and the interest acquired and property description is more particularly described as follows:

Parcel No. 0067:6D:A

A parcel of land in fee for a freeway known as Project No. 0067, being part of an entire tract of property, situate in Lot 8 of Section 10, T. 1 N., R. 1 W., S.L.B. & M. The boundaries of said parcel of land are described as follows:

Beginning in the westerly highway right of way and no-access line of the existing I-215 Freeway at a Northeast corner of said entire tract, which point is approximately 130.178 m (427.09 ft.) north (equals highway N 0°20'45" E) and 110.609 m (362.89 ft.) east (equals highway S 89°39'15" E) from the Southwest corner of said Section 10 as monumented with a county Brass Cap; and running thence Southerly 21.108 m (69.25 ft.) along said westerly

The above described parcel of land contains 366.3 square meters (0.091 acre), more or less.

Together with any and all water rights appurtenant to the above described parcel of land.

To enable the Utah Department of Transportation to construct and maintain a public highway as a freeway, as contemplated by Title 78, Chapter 34, Section 5, Utah Code Annotated, 1998, as amended, the Owners of said entire tract of property hereby release and relinquish to said Utah Department of Transportation any and all rights appurtenant to the remaining property of said Owners by reason of the location thereof with reference to said highway, including, without limiting the foregoing, all rights of ingress to or egress from said Owner's remaining property contiguous to the lands hereby conveyed to or from said highway.

Parcel No. 0067:7B:A

A parcel of land in fee for a freeway known as Project No. 0067, being part of an entire tract of property, situate in the Lot 8 of Section 10, T. 1 N., R. 1 W., S.L.B. & M. The boundaries of said parcel of land are described as follows:

Beginning in the westerly highway right of way and no-access line of the existing I-215 Freeway at the Northeast corner of said entire tract, which point is approximately 281.887 m (924.83 ft.) N 0°20'45" E (deed of record North) and 174.219 m (571.58 ft.) S 89°49'57" E (deed of record East) from the Southwest corner of said Section 10 as monumented with a county Brass Cap; and running thence Southerly 133.438 m (437.79 ft.) along said westerly highway right of way and no-access line, along the arc of a 914.347 m (2,999.83 ft.) radius curve to the left, to a point opposite Engineer Station 6001+845.027 (Note: Chord to said curve bears S 24°01'01" W for a distance of 133.319 m (437.40 ft.)); thence N 24°11'31" W 11.422 m (37.47 ft.); thence N 17°35'33" E 18.737 m (61.47 ft.); thence N 20°03'21" E 99.593 m (326.75 ft.), more or less, to the northerly boundary line of said entire tract; thence S 89°49'57" E (deed of record East)

Together with any and all water rights appurtenant to the above described parcel of land.

To enable the Utah Department of Transportation to construct and maintain a public highway as a freeway, as contemplated by Title 27, Chapter 12, Section 96, Utah Code Annotated, 1953, as amended, the Owners of said entire tract of property hereby release and relinquish to said Utah Department of Transportation any and all rights appurtenant to the remaining property of said Owners by reason of the location thereof with reference to said highway, including, without limiting the foregoing, all rights of ingress to or egress from said Owner's remaining property contiguous to the lands hereby conveyed to or from said highway.
