PARTIAL TERMINATION OF RIGHT OF FIRST REFUSAL AGREEMENT

THIS PARTIAL TERMINATION OF RIGHT OF FIRST REFUSAL AGREEMENT (this "Agreement") is dated as of April 20th, 2020 (the "Effective Date"), by and among GARDNER JORDAN BLUFFS, L.C., a Utah limited liability company ("Gardner"), and WASATCH RESIDENTIAL GROUP, LLC, a Utah limited liability company ("Wasatch"). The foregoing are sometimes referred to individually as a "Party" and collectively as the "Parties."

RECITALS

- A. The Parties entered into that certain Right of First Refusal Agreement dated November 16, 2017 and recorded in the official records of Salt Lake County, Utah, on November 16, 2017 as Entry No. 12660564, in Book 10620, beginning on Page 4487 (as modified or amended, the "**ROFR Agreement**").
- B. The ROFR Agreement encumbers certain real property situated in Salt Lake County, State of Utah, and described on Exhibit A to such ROFR Agreement (the "**Property**").
- C. Gardner has entered into an agreement to sell a certain portion of the Property legally described on <u>Exhibit A</u> hereto (the "**Release Property**") to a third-party. The sale of the Release Property is referred to hereinafter as the "**Transaction**".
- D. In connection with the Transaction, and for good and valuable consideration, the Parties desire to partially terminate the ROFR Agreement, but only with respect to the Release Property.

AGREEMENT

- 1. <u>Partial Termination</u>. The Parties hereby fully, finally and forever terminate the ROFR Agreement, and all obligations of the Parties thereunder (including, without limitation, any rights and obligations of any Party which, by their express terms, survive the termination of the ROFR Agreement), but only with respect to the Release Property.
- 2. <u>Limitation</u>. For clarity, the Parties desire that the ROFR Agreement remain in force for all Property except for the Release Property and except as modified by this Agreement.

- 3. <u>Consent to Transaction</u>. By its execution hereof, Wasatch hereby: (i) consents to the Transaction described in this Agreement and the release of the Release Property; (ii) waives any right of notice, first refusal, first offer, or any other rights afforded to Wasatch under the ROFR Agreement with respect to the Release Property and the Transaction; and (iii) releases the Release Property and the Transaction from any and all claims and interests arising from the ROFR Agreement.
- 4. <u>Interpretation</u>. Any inconsistency between the terms of the ROFR Agreement and the terms of this Agreement shall be governed by the terms of this Agreement.
- 5. <u>Binding Nature</u>. This Agreement shall inure to the benefit of and bind the parties hereto and their respective heirs, executors, administrators, personal representatives, successors and assigns.
- 6. **Governing Law.** This Agreement shall be construed in accordance with the laws of the State of Utah.
- 7. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which shall constitute an original and all of which shall constitute but one and the same document.


