Pursuant to ARTICLE III of the Declaration, and Sections 57-8-13 (3) and 57-8-13.4 of the Act, Declarant has caused a First Supplemental Record of Survey Map and this First Amendment of Declaration to be prepared for simultaneous recordation in the Public Records in order to convert certain Convertible Space in the Project into additional Units as reflected on the First Supplemental Record of Survey Map.

D. The real property to which this First Amendment to Declaration and the First Supplemental Record of Survey map are applicable is located in Orem, Utah County, Utah, and is described as follows:

The project is hereby divided into __9_ Condominium Units and Convertible Space, as set forth on the Map. In addition to fee title to a Unit, each Unit's Owner shall have an appurtenant, undivided ownership interest in and to the Common Areas and Facilities to the extent set forth in Amended Exhibit A, attached hereto and incorporated herein by this reference.
 - (b) Exhibit A to the Declaration is amended in its entirety to read as set forth in Amended Exhibit A, attached hereto and made a part hereof.
- Except as amended by the provisions of this First Amendment to Declaration, the Declaration shall remain unchanged and shall constitute the entire Declaration of Condominium for the Project, reflecting the conversion of portions of the Convertible Space as described on the First Supplemental Record of Survey Map and the attached Amended Exhibit A.
- This First Amendment to Declaration shall be recorded in the Public Records simultaneously with the Project's First Supplemental Record of Survey Map, consisting of two sheets prepared by Roger D. Dudley, a Utah registered land surveyor holding Certificate No. 147089. Both such instruments shall be effective upon recordation.
