

**FIRST AMENDMENT TO THE DECLARATION OF
CONDOMINIUM FOR BLACK ROCK RIDGE CONDOMINIUM,
an Expandable Utah Condominium Project**

THIS FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM for BLACK ROCK RIDGE Condominium, an expandable Utah Condominium Project (the "First Amendment to the Declaration") is adopted this 21st day of March, 2007, by Iroquois Partners, LLC, a Utah limited liability company, 758 South 400 East, Orem, Utah 84097 (the "Declarant"). The Declarant intends that this First Amendment to the Declaration shall amend the Declaration of Condominium for Black Rock Ridge Condominium, recorded with the Wasatch County Recorder on September 25, 2006 as Entry No. 308173, in Book 894, at Pages 37-107 (the "Declaration"), as follows:

1. Any reference in the Declaration to Black Rock Ridge, LC as the Declarant shall be and hereby is replaced with Iroquois Partners, LLC, a Utah limited liability company, as Declarant.

2. Specifically, on page two of the Declaration, the first paragraph reads as follows:

"This Declaration of Condominium for BLACK ROCK RIDGE Condominium, an expandable Utah Condominium Project, is made and executed by BLACK ROCK RIDGE, L.C., a Utah limited liability company, of 758 South 400 East, Orem, Utah 84097 (the "Declarant")."

This paragraph shall be replaced in its entirety with the following paragraph:

"This Declaration of Condominium for BLACK ROCK RIDGE Condominium, an expandable Utah Condominium Project, is made and executed by IROQUOIS PARNTERS, LLC, a Utah limited liability company, of 758 South 400 East, Orem, Utah 84097 (the "Declarant")."

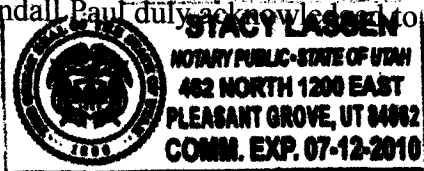
