and right of way for the erection and continued maintenance, repair, alteration, and replacement of  
the electric transmission, distribution and telephone circuits of the Grantee, and  
..... two guy anchors and two ~~towers or~~ poles, with the necessary guys, stubs, crossarms and  
other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and main-  
tained upon and across the premises of the Grantor..., in ..... Davis ..... County, Utah,  
along a line described as follows:

Beginning on the west boundary line of grantor's land at a point 1319 feet  
north and 660 feet east, more or less, from the south quarter corner of Section 4,  
T.4 N., R.1 W., S.L.M., thence S.89°27'E. 660 feet, more or less, to the east  
boundary line of said land and being in the SW 1/4 of the SE 1/4 of said Section 4.

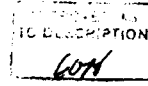
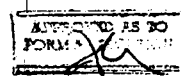
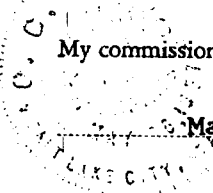
