**SECOND AMENDED NOTICE OF REINVESTMENT FEE COVENANT**  
(Edgewater at Geneva Owners' Association, Inc.)

---

Pursuant to Utah Code § 57-1-46, Edgewater at Geneva Owners' Association, Inc. ("Association") hereby provides notice that this Second Amended Notice of Reinvestment Fee Covenant (hereinafter referred to as "Reinvestment Fee Covenant") affects the real property described in Exhibit A (the "Burdened Property"). The Reinvestment Fee Covenant was recorded as part of the Second Amended and Restated Declaration of Covenants, Conditions, and Restrictions for Edgewater at Geneva P.U.D (the "Declaration") recorded with the Utah County Recorder on February 2, 2016, as Entry No. 8619: 2016, in the official records of the Utah County Recorder's Office. The Declaration and any amendments or supplements thereto, establishes certain obligations of which all owners, sellers, and buyers should be aware.

**BE IT KNOWN TO ALL OWNERS, SELLERS, BUYERS, AND TITLE COMPANIES** owning, purchasing, or assisting with the closing of a Burdened Property conveyance within the Association that:

1. The Edgewater at Geneva Owners' Association, Inc. is the beneficiary of the Reinvestment Fee Covenant. The Association's address for their registered agent, as of the date of this notice, is 460 East, 800 North, PO Box 1006, Orem, UT 84059.

The address for the Association's registered agent, or any other representative of the Association, may change from time to time; therefore, any party requesting information from or making payment to the Association should verify the most current address for the Association on file and of record with the Utah Division of Corporations and/or Utah Department of Commerce Homeowners Associations Registry.

2. The burden and obligation of the Reinvestment fee covenant is intended to benefit the Burdened Property. The purpose of the fee paid under the Reinvestment Fee Covenant is to cover costs of the Association of effectuating any transfer of ownership or membership upon the books and records of the Association, to perpetuate the reserve funds of the Association, and/or to reduce the common expenses of the Association.

3. The existence of the Reinvestment Fee Covenant precludes the imposition of an additional reinvestment fee covenant on the Burdened Property.

4. The amount of the Association's reinvestment fee is established by the Association's Board of Directors through a resolution in accordance with Utah law and pursuant to the Association's Declaration and may be changed by the Board of Directors as allowed by the Declaration and in accordance with Utah law.
