The following is a description of the property so ordered and condemned as hereinabove provided, which is hereby vested in fee simple title in the plaintiff, all of such property being situated in Salt Lake County, State of Utah, and is more particularly described as follows:

## Parcel No. 0134:93

A parcel of land in fee for a highway known as Project No. 0134, being part of an entire tract of property, in Lot 2 of Section 27, T. 1 S., R. 1 W., S.L.B.&M. The boundaries of said parcel of land are described as follows:
