In order to construct and maintain a public highway as an expressway, as contemplated by Title 27, Chapter 12, Section 96, Utah Code Annotated, 1953, as amended, the Grantor hereby agrees to the following: As to Parcel No. JDR-RA-8, Grantor agrees to release and relinquish to the United States, or its assigns, any and all rights or easements appurtenant to the Grantor's remaining property by reason of the location thereof with reference to said highway, including, without limiting the foregoing, all rights of ingress to or egress from the Grantor's remaining property contiguous to the lands hereby conveyed, to or from said highway; EXCEPTING and reserving to the Grantor, successors or assigns, the right of access to the nearest roadway of said highway over and across the right-of-way line to the right of said highway for three 16-foot openings, which said openings center at points directly opposite Highway Engineer Stations 242+20.00, 252+00.00, and 293+85.00. Also, the right of access to the nearest roadway of said highway over and across the right-of-way line to the left of said highway for three 16-foot openings, which said openings center at points directly opposite Highway Engineer Stations 230+40.00, 244+00.00, and 263+00.00.
