## NEIGHBORHOOD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF SUN RIVER ST. GEORGE

This Amendment to the Declaration was approved and will be recorded within the Development Period and is recorded for the purpose of redesignating the Neighborhood boundaries.
- Prior to September 2003 no official Neighborhood designation had occurred and by default the Project consisted of a single Neighborhood, There were, however, unofficial delineations of the Project into "Areas". This Amendment resolves any misconceptions in relation to the unofficial Project "Areas" and "Area Representatives" and properly designates the Neighborhoods in connection with the functions of Neighborhood Representatives as more fully provided for in the Declaration.
- This Amendment shall apply to and be recorded against the following real proper(v) all located in Washington County, State of Utah:
