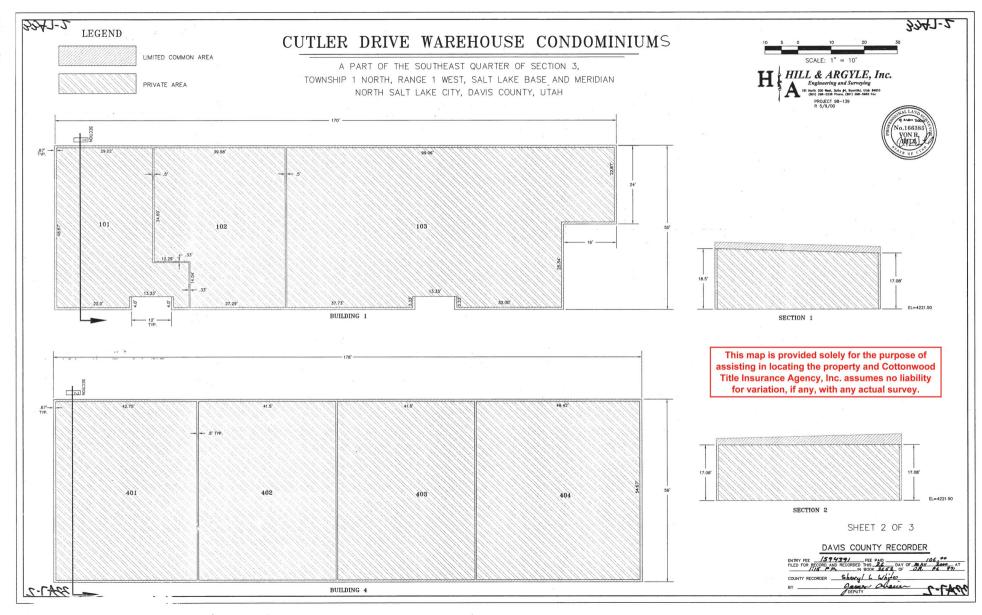

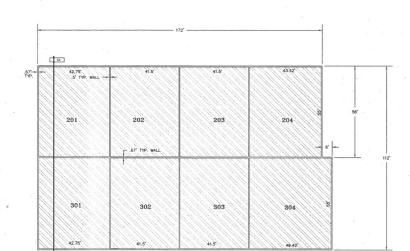

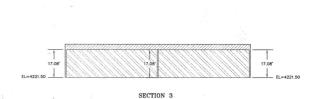
LIMITED COMMON AREA PRIVATE AREA
