## ADMINISTRATIVE RESOLUTION FOR THREE FOUNTAINS NORTH HOA RESPONSIBILITY FOR MAINTENANCE OF STORAGE SHEDS WITH ATTACHED CARPORTS (Limited Use Common Area) AND THE PAYMENT THEREOF

Whereas Three Fountains North HOA has a Declaration and other governing documents, and,

Whereas Article 1.m (definition of Limited Use Common Areas), Article 4.b (assignment of Limited Use Common Areas), and Article 6.b (Management's responsibility for maintenance of all Common Areas), and

Now therefore, be it resolved that the following procedures will be followed as they pertain to the Limited Use Common Area Sheds with Attached Carports:

- \*All insurance, utilities and maintenance (exteriors such as but not limited to paint, roofs, and structure maintenance) of the Sheds and Attached Carports will be arranged for and invoices paid by the HOA Management Committee,
- \*Costs of such insurance, utilities and exterior maintenance of said Sheds and Attached Carports will be borne by those to whom the Sheds and Attached Carports have been assigned (those unit owners who benefit from use of said limited use common area),
- \*Each of the assignees will be assessed a yearly fee of fifty (50) dollars to cover the ongoing costs of said insurance, utilities, and exterior maintenance of said Sheds and Attached Carports,
- \*Said assessments will be declared to assignees no less than thirty (30) days prior to their due date of January 1st of each year,
- \*Assessments will be due January 1st of each year with a late fee being assessed if payment is not received by January 10th of each year,
- \*Assignees will notify the Management Committee when they are aware of any maintenance that needs to be performed on the Sheds with Attached Carports so maintenance can be arranged,
- \*Assignees will notify the Treasurer whenever the assignment is transferred to another resident (must be an owner in Three Fountains) so proper documentation can be kept.
