## ADMINISTRATIVE RESOLUTION FOR THREE FOUNTAINS NORTH HOA SCHEDULE OF FINES FOR VIOLATIONS OF GOVERNING DOCUMENTS

Whereas Three Fountains North Homeowners Association has a Declaration, Bylaws and Rules and Regulations, and,

Whereas Article 6 Sections e and g of the CC&R's and Article IV Section 1 of the Bylaws for Three Fountains North empower the HOA Management Committee to enforce the Declaration, Bylaws, and the Rules and Regulations, and

Now, therefore, be it resolved that the Three Fountains North Association will enforce said Declaration, Bylaws, and Rules and Regulations with the following procedure, upon receipt of an alleged rule violation letter/phone call stating the date and approximate time of the violation, a letter will be sent to the alleged violator stating the alleged violation and a time period during which the alleged violation may be abated with further sanction (not less than 72 hours).

1st Offense:

Written Warning

Up to \$500.00

Written Notice shall include the following: that a fine may be levied should that violation not be cured within 72 hours. The owner is entitled to a hearing within 14 days of the notice with the Management Committee at a meeting called for that purpose. PLEASE BRING ALL SUPPORTING DOCUMENTATION TO JUSTIFY REMOVAL OF FINES.

After 14 days expires, if no hearing is requested, or after a final decision after hearing, the Association can levy late fees and interest on the fines pursuant to the declaration, bylaws, and rules and regulation after account is 30 days delinquent.

Collection of unpaid fines shall be conducted in the same manner as collections of unpaid assessments.
