GRANT OF RIGHT OF WAY

THIS GRANT, made this 28 day of MARCH, 1940, between
the SECURITY STORAGE & COMMISSION COMPANY, a corporation of the
State of Utah, Grantor, and CHARLES FRANCIS HEGNEY and GLADYS
MARIE PETERSON, Grantees,

W I T N E S S E T H :

THAT WHEREAS, the Grantor is the owner of part of Lot
Block 63, Plat "A", Salt Lake City Survey, State of Utah, and
the Grantees are the owners of the hereinafter described parcel
of land, being a part of Lot 5, Block 63, Plat "A", Salt Lake
City Survey, State of Utah, to-wit:

Beginning at the Northwest corner of said
Lot 5 and running thence South 10 rods;
thence East 12 rods; thence North 10 rods;
thence West 12 rods, to the place of beginning.

AND WHEREAS, the Grantees are the owners of a right of
way granted them by the Grantors in a certain grant of Right of
Way dated January 27, 1935, and recorded in the office of the
County Recorder of Salt Lake County on January 28, 1935, said
right of way being described as follows:

Beginning at a point 1 rod West of the North-
east corner of said Lot 4 above described;
running thence West to a point 120 feet East
of the Northwest corner of said Lot 4; thence
South 12 feet; thence East to a point 1 rod
West of the East boundary line of said Lot 4;
thence North 12 feet to the place of beginning.

AND WHEREAS, the Grantees are desirous of having a
portion of said right of way increased in width to the extent
of two (2) feet, making said right of way fourteen (14) feet wide;

NOW, THEREFORE, in consideration of the premises and
of the payment of the sum of \$10.00 by the Grantees to the Grantor,
the receipt of which is hereby acknowledged, the Grantor hereby
gives and grants unto the Grantees, as an appurtenance to the
said lands of the Grantees above described, a perpetual right of
way for vehicles and pedestrians over and across the following

described strip or parcel of land, to-wit:

Beginning at a point 12 feet South 0 deg.
03' 53" East from the Northeast corner
of said Lot 4 above described, running
thence West 175 feet; thence South 0 deg.
03' 53" East 2 feet; thence East 175 feet;
thence North 0 deg. 03' 53" West 2 feet
to the place of beginning.

The Grantor reserves the right to use said parcel or
right of way for right of way in common with the Grantee,
their heirs and assigns, and with the privilege of conveying to
the adjoining property owners similar rights of way.
