DEED OF DEDICATION

CORNER CANYON PROPERTIES, L.L.C., Grantor, hereby deeds to **DRAPER CITY**, a Utah municipal corporation, Grantee, and dedicates for public use for the sum of ten dollars and other valuable consideration, the following real property in Utah County, State of Utah:
